(1) The cost of additional payments made to various entities for FICA, Medicare, IMRF, Pension and Deferred Compensation ranged from \$943 to \$34,645.

(2) Salary includes salary, hourly pay, stipends, overtime, holiday pay, officer in charge pay, vacation, sick and personal time paid.

(3) Vacation Days Granted ranged from 0 to 20. Sick Days Granted ranged from 0 to 10.

(4) Health Insurance Waiver includes payment to the employee for waiving Village health insurance coverage. The cost of health, dental and life insurance payments to providers ranged from \$0 to \$19,950.
