ISSUE

Shall the Village Board hold a public hearing to collect comments from the public concerning the extension of the current Yorkville-Sugar Grove boundary line agreement.

DISCUSSION

The Committee of the Whole discussed this matter at its August 2, 2016 meeting. There is currently a boundary line agreement in effect between the United City of Yorkville and the Village of Sugar Grove and is due to expire in 2020. The leadership in both communities has determined it would be in the best interests of both communities to extend the life of the current agreement in the absence of development pressure. The Committee agreed to move forward with the process to extend the expiration date of the boundary line agreement.

PROPOSED RENEWAL OF BOUNDARY AGREEMENT
BETWEEN THE VILLAGE OF SUGAR GROVE AND
THE UNITED CITY OF YORKVILLE**

NOTICE is hereby given that the Village of Sugar Grove and the United City of Yorkville are considering the renewal of a Boundary Agreement establishing a jurisdictional boundary line between the two municipalities pursuant to the provisions of Section 5/11-12-9 of the Illinois Municipal Code (65 ILCS 5/11-12-9) for territory located between the two villages and on either side of a line running generally along Base Line Road from a point in Section 2 in Sugar Grove Township to a point in Section 35 in Blackberry Township, as set forth in greater specificity on the Jurisdictional Boundary Line Map. It is anticipated that the boundary line to be established shall be substantially the same as the existing boundary line.

The proposed boundary line agreement will be reviewed by the Village Board at a public meeting to be held on August 16, 2016 at 6:00 p.m. at Village Hall, located at 10 South Municipal Drive, Sugar Grove, Illinois. All interested parties wishing to comment may address the Village Board at this meeting and/or may submit written comments to the Village Clerk at the address below.
