AN ORDINANCE REPEALING ORDINANCE 20100615C

BE IT ORDAINED by the Board of Trustee of the Village of Sugar Grove, Kane County, Illinois as Follows:

WHEREAS the Village of Sugar Grove has previously enacted an Ordinance Establishing SSA #16, Ordinance 20100615C of the Village of Sugar Grove”; and

WHEREAS the Board of Trustees of the Village of Sugar Grove desires to repeal such said ordinance;

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Sugar Grove, Kane County, Illinois as Follows:

SECTION 1:

That Ordinance 20101015C is hereby repealed and to the extent that this ordinance is in conflict with any presently existing ordinances or portions thereof, enforced in the Village of Sugar Grove as of the effective date hereof, such prior and conflicting ordinances or parts thereof are hereby repealed.

The repeal of any ordinance by this ordinance shall not affect any right accrued or liability incurred under such repealed ordinance to the effective date hereof.

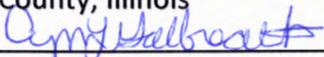
SECTION 2: EFFECTIVE DATE
