A Resolution  
Authorizing the Modification of Residential Water Service Connection Fees  
for the Village of Sugar Grove, Kane County, Illinois

**WHEREAS**, the Village of Sugar Grove maintains and provides a public water system; and,

**WHEREAS**, the Village of Sugar Grove authorizes connections to the system and charges a connection or tap-on fee for such connections; and,

**WHEREAS**, the Board of Trustees of the Village of Sugar Grove are authorized, pursuant to Section 8-1-6(C) of the Village Code to modify the amount charged as the Connection Tap-On Fee for residential water service connections to the Village water system; and,

**WHEREAS**, the Board of Trustees find that the Village of Sugar Grove water system will need extensive improvements to accommodate future growth of the Village; and,

**WHEREAS**, the Board of Trustees finds that the connection tap-on fee helps fund improvements to the water system; and,

**WHEREAS**, the Board of Trustees thus finds that it is in the best interests of the Village to modify the amount charged as the connection tap-on fee;

**NOW, THEREFORE, BE IT RESOLVED** by the Village President and the Board of Trustees of the Village of Sugar Grove as follows:

The rate charged as the Connection Tap-On fee for single family detached residential water service connections to the Village water system shall be as follows:

Connection Size in Inches	Rate per Connection
1.0	\$5,801.00
1.5	\$8,701.50
2.0	\$11,602.00
3.0	\$17,403.00
4.0	\$23,204.00
6.0	\$34,806.00
Greater than 6	\$5,801.00 per inch

The rate charged as the Connection Tap-On fee for multi-family residential water service connections to the Village water system shall be the single family detached residential

water service connection fee for the one inch connection size multiplied by the number of residential units in the multi-family building served by any single connection.

This resolution shall be in full force and effect as of the **1<sup>st</sup> Day of May, 2006.**
