(3) Vacation Days Granted ranged from 0 to 20. Sick Days Granted ranged from 0 to 10.

(4) Health Insurance Waiver includes payment to the employee for waiving Village health insurance coverage. The cost of health, dental and life insurance payments to providers ranged from \$0 to \$19,976.
