ISSUE

Should the Village/Board approve the purchase of 14 TASERS for Police Department.

DISCUSSION

Fiscal Year 2016-2017 Budget includes funds of \$14,471 to purchase TASERS for the police department. TASER International has provided two options to purchase the TASERS. One way is to buy them outright and the other way is to spread the cost out over a five year period. The five year period pricing model offers a cost savings to the Village as we can trade in three of our current TASERS for new replacement ones. The three units to be traded in are at the end of their life cycle.

Currently we have a pool of four TASERS available for the full-time and part-time officers to sign out for on their respective shift. Many times, no TASER is available for the officer to check out due to unforeseen circumstances.

The Police Department would like to outfit each full-time officer with their own TASER and have a pool of four additional TASER's that would be checked out by the part-time officers. Accountability and physical care by the officers will better serve the department as the wear and tear should be diminished as they will be in the physical control of one officer vs. sharing with others. The police department is requesting to purchase 14 TASERS in order outfit all shifts and officers so that they have an available to them a less lethal control option when needed.

OPTION ONE: to purchase outright for \$27,224.96 plus shipping and handling for 14 TASERS with accessories including a five year warranty.

OPTION TWO: to break it out over a five year period billed yearly and paying at the end of the five years a total of \$25,740 plus shipping and handling. (The first year cost is

\$4,908 due to trade in of three of our existing TASERS. Years 2 through 5 our payment would be \$5,208 per year for a total of \$25,740 plus shipping and handling.)

Staff recommends the OPTION TWO as we currently have \$14,471 in the budget to purchase TASERS. NOTE: The police department would have a re-occurring expense each year under this option if selected moving forward and include it in our fiscal annual budget. (The remaining difference of the original budgeted amount and actual first year costs would leave \$9,563 in this fiscal year's budget)

COST

The cost for purchasing 14 TASERS over a five year period is \$25,740 with the first year of \$4,908 and years two through five annually at \$5,908. This Fiscal Year 2016-2017, account 01-51-6500 includes \$14,471 for new TASERS.

RECOMMENDATION

That the Village Board directs staff as to the option and further Adopts a Resolution Approving the Purchase of TASERS with TASER International.
