ISSUE

Shall the refuse rate for the Village of Sugar Grove be amended.

DISCUSSION

The Village Board approved a new contract with D.C. Trash effective August 2017. In accordance with the contract, the increase thereafter will be 3% annually. In the D.C. Trash contract, the Village saw a decrease in the monthly household cost for refuse. Therefore, Staff recommends a decrease of \$5.59 from \$23.34 to \$17.75. The new rate will be in effect for the August 1, 2017, utility bills.

Attached is the resolution to change the refuse rate. At this time, the attorney fees for the contract negotiations are unknown, which does not give a good depiction of the current fund balance and reserve requirement. The reserve requirement and fund balance can be revisited at another time.
