ISSUE

Should the Village Board approve the purchase of a replacement Chevy Silverado 2500HD 4x4 with snow plow.

DISCUSSION

The FYE 2018 budget included funds to purchase a replacement Chevy Silverado 2500HD 4x4 with snow plow. Staff solicited bids from nine local dealers, advertised in the newspaper and Village website. Two bids were received, only 1 of the bids meet specifications. The prices below reflect trade in of our current 2002 F-350 4x4 Utility Truck with snow plow. The price of the truck compared to the budget amount is due to replacing a utility truck with a standard pick-up truck.

COST
