ISSUE

Should the Village approve a Collective Bargaining Agreement (CBA), with the Illinois Fraternal Order of Police (FOP), representing Patrol Officers.

DISCUSSION

The current CBA between the Village and the Patrol Officers expires on April 30, 2019. The proposed new CBA will cover the period May 1, 2019 – April 30, 2023.

The Patrol Officers are expected to ratify the new CBA prior to the Village Board meeting.

If Board Members have any questions regarding the proposed CBA, they should be presented in Closed Session prior to the vote. The proposed CBA should remain confidential until approved.
