ISSUE

Shall the Village Board hold a public hearing to consider amending the Crown Community Development annexation agreement.

DISCUSSION

The Village Board opened the public hearing on May 15, 2018 continued it to June 5, June 19, July 10, July 24, August 21, September 4, October 2, November 6, December 4, 2018, and to Janaury 8, 2019.

The applicant and owner, Crown Community Development, is requesting an amendment of the annexation agreement in order to faciliate construction and development of the subject property and the resulting changed assumptions about development in the market.

Despite all the best efforts of the parties, the annexation agreement amendment is not ready to present to the Village Board and the public hearing needs to be continued.
