ORDINANCE 20190521A

An Ordinance Amending Title 1, Chapter 8, Section 2 Of the Code of Ordinances of the Village of Sugar Grove, Kane County, Illinois
For the Village of Sugar Grove, Illinois

BE IT ORDAINED by the President and Board of Trustees of the Village of Sugar Grove, Kane County, Illinois, as follows;

WHEREAS, the Village is not a home rule municipality within Article VII, Section 6A of the Illinois Constitution and, pursuant to the powers granted to it under 65 ILCS 5?3.1-300-5:

WHEREAS, the President and Board of Trustees of the Village of Sugar Grove have determined that it is in the best interests of the Village and its citizens to amend the Code of Ordinances for the Village of Sugar Grove.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Sugar Grove, Kane County, Illinois, as follows:

SECTION ONE: Title 1, Chapter 8, Section 2, of the Sugar Grove Village Code is Hereby amended as follows:

G. Visitors: Except during the time allotted for public discussion and comment, no person, other than a member of the board, shall address that body, except with the consent of two (2) of the members present. Members of the public wishing to address the board shall adhere to the following rules and procedures:

1. Visitors desiring to address the Board shall raise their hand when the call for public comment is given. The Village President will recognize members of the public at which time they may address the Board.
2. Individual comment is limited to three (3) minutes. The Village President will notify the speaker when time has expired.
3. Persons addressing the Board shall refrain from commenting about the private activities, lifestyles, or beliefs of others, including Village employees and elected officials, which are unrelated to the business of the Village Board. Also, speakers should refrain from comments or conduct that is uncivil, rude, vulgar, profane, or otherwise disruptive. Any person engaging in such conduct shall be requested to leave the meeting.
4. The aforementioned rules pertaining to public comment may be waived by the Village President, or by a majority of a quorum of the Village Board

SECTION TWO: To the extent that this ordinance is in conflict with any presently existing ordinances or portions thereof enforced in the Village Of Sugar Grove as of the effective date hereof, such prior and conflicting ordinances or portions thereof are hereby repealed. The repeal of any ordinance by this Ordinance shall not affect any right accrued or liability incurred under such repealed ordinance to the effective date hereof.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
