**ISSUE**

Shall the Village Board hold a public hearing to collect comments from the public concerning the restatement and extension of a boundary line agreement with the City of Plano.

**DISCUSSION**

The leadership in both communities has determined it would be in the best interests of both communities to restate, renew and extend the expiration date of the current boundary line agreement between the Village and the City of Plano. The current Agreement is set to expire on April 19, 2025. The extension will extend the expiration date to May 1, 2040. The boundary agreement line is generally the Kane-Kendall county line from Granart Road to IL 47 and will remain unchanged with the new Agreement.

**NOTICE OF PUBLIC HEARING  
PROPOSED AMENDMENT OF BOUNDARY AGREEMENT BETWEEN THE  
VILLAGE OF SUGAR GROVE AND CITY OF PLANO**

**NOTICE** is hereby given that the Village of Sugar Grove and the City of Plano are considering extending the expiration date of a Boundary Agreement establishing a jurisdictional boundary line between the two municipalities pursuant to the provisions of Section 5/11-12-9 of the Illinois Municipal Code (65 ILCS 5/11-12-9) for territory located between the two municipalities and on either side of a line beginning at State Route 47 in Sugar Grove Township and running generally along the Kane-Kendall County line to Granart Road in Big Rock Township, as set forth in greater specificity on the Jurisdictional Boundary Line Map.

The proposed boundary line agreement, particularly an extension of the expiration date of said agreement, including the Jurisdictional Boundary Line Map, will be considered by the Village Board at a public hearing to be held on July 21, 2020 at 6:00 p.m. at Village Hall, located at 10 South Municipal Drive, Sugar Grove, Illinois. All interested parties wishing to comment may address the Village Board at this meeting and/or may submit written comments to the Village Clerk at the address below.

Also be advised, due to the COVID-19 pandemic, there are special procedures in effect for conducting public meetings, including public hearings. This meeting will be conducted by electronic means. **AGREEMENT RESTATING, EXTENDING AND RENEWING  
JURISDICTIONAL BOUNDARY LINE AGREEMENT  
BETWEEN THE CITY OF PLANO, ILLINOIS  
AND  
THE VILLAGE OF SUGAR GROVE, ILLINOIS**

WHEREAS, effective as of the 3<sup>rd</sup> day of May, 2005, the CITY OF PLANO, ILLINOIS, and the VILLAGE OF SUGAR GROVE, ILLINOIS, entered into a JURISDICTIONAL BOUNDARY LINE AGREEMENT BETWEEN THE CITY OF PLANO, ILLINOIS, AND THE VILLAGE OF SUGAR GROVE, ILLINOIS, a copy of which is attached hereto and made a part hereof; and

WHEREAS, said Agreement is still in full force and effect and expires in the year 2025; and

WHEREAS, the parties hereto desire to reaffirm, restate, and extend the term of said Agreement to and including May 1, 2040; and

WHEREAS, prior to the execution of this Agreement, each of the parties hereto not less

than thirty (30) days and not more than one hundred twenty (120) days prior to the formal approval hereof by the respective corporate authorities, have provided public notice of the proposed Boundary Agreement and the Restatement, Extension, and Renewal thereof by both of the following: (1) the posting of a public notice for not less than fifteen (15) consecutive days in the same location at which notices of Village Board or City Council Meetings are posted; and (2) publication on at least one (1) occasion in a newspaper of general circulation within the territory that is subject to the Agreement.

NOW, THEREFORE, upon consideration of the mutual promises contained herein and upon further consideration of the recitals hereinabove set forth, it is hereby agreed between the CITY OF PLANO and the VILLAGE OF SUGAR GROVE, as follows:

1. All of the terms and provisions of the JURISDICTIONAL BOUNDARY LINE AGREEMENT BETWEEN THE CITY OF PLANO, ILLINOIS, AND THE VILLAGE OF SUGAR GROVE, ILLINOIS, a copy of which is attached hereto and made a part hereof, are ratified and confirmed.

2. Unless sooner terminated by mutual agreement of the parties, the Agreement shall expire on May 1, 2040.

IN WITNESS WHEREOF, THE CITY OF PLANO and THE VILLAGE OF SUGAR GROVE have caused this AGREEMENT RESTATING, EXTENDING, AND RENEWING JURISDICTIONAL BOUNDARY LINE AGREEMENT BETWEEN THE CITY OF PLANO, ILLINOIS, AND THE VILLAGE OF SUGAR GROVE, ILLINOIS, to be executed by their respective Mayor/Village President and attested by their respective City/Village Clerk, pursuant to Ordinances adopted by each municipality authorizing the execution of this AGREEMENT RESTATING, EXTENDING, AND RENEWING JURISDICTIONAL BOUNDARY LINE

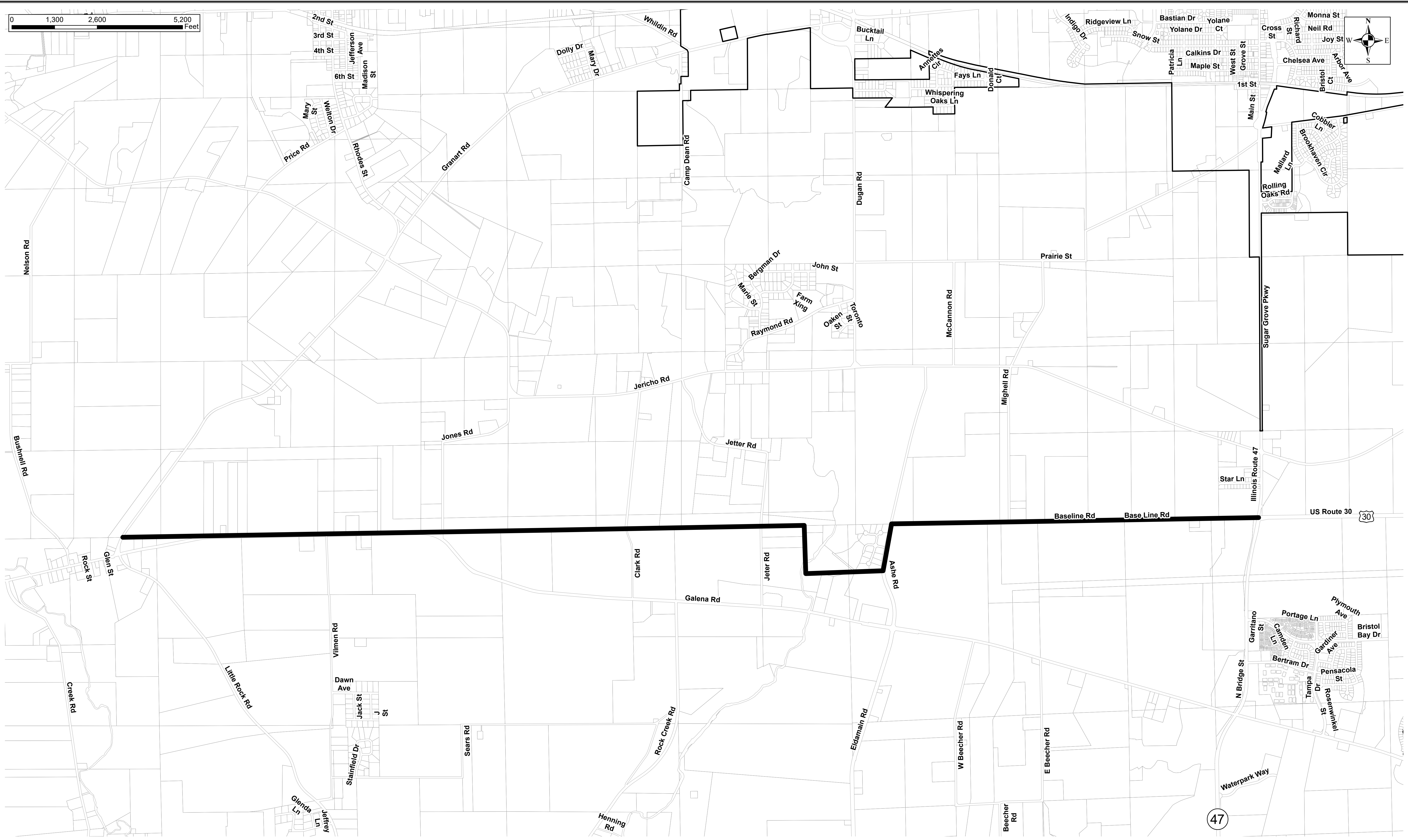
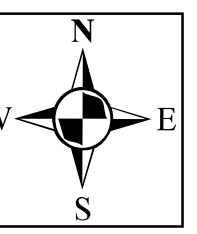
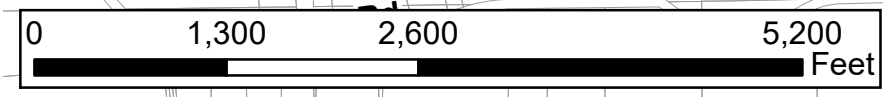
