ISSUE

Should the Village Board approve an ordinance repealing and amending Title 3, Chapter 11 - Raffles.

DISCUSSION

At the October 6, 2020 Village Board meeting, the Board discussed and reached consensus to return the issuance of raffle licenses to Kane County through an intergovernmental agreement. Prior to approving the IGA, an ordinance repealing and amending Title 3, Chapter 11 – Raffles must be approved to allow for the change.

COST

There will be no reduction in revenues as raffle license revenue is not included in the current budget due to the small amount. Attorney costs to review and prepare necessary documentation is estimated at less than \$200.

RECOMMENDATION

That the Board approve an ordinance repealing and amending Title 3, Chapter 11 - Raffles.

ORDINANCE NO. 20201020A

**An Ordinance Repealing and Amending Title 3, Chapter 11 - Raffles
Village of Sugar Grove, Kane County, Illinois**

BE IT ORDAINED, by the Board of Trustees of the Village of Sugar Grove, Kane County, Illinois as follows:

WHEREAS, the Village of Sugar Grove (“Village”) is not a home rule municipality within Article VII, Section 6A of the Illinois Constitution, and accordingly, seeks to act pursuant to the powers granted to it under 65 ILCS 5/1-1 *et seq.*; and,

WHEREAS, since the adoption of Chapter 11 – Raffles, the Village has determined it is in the best interest of the Village to enter into an Intergovernmental Agreement with Kane County (“County”) to delegate its raffle licensing authority to the County; and,

WHEREAS, as such, the Village finds that Chapter 11 – Raffles is no longer necessary or useful for the Village to have contained in its Village Code of Ordinances; and,

WHEREAS, the President and Board of Trustees of the Village of Sugar Grove have determined that it is in the best interests of the Village and its citizens to amend the Code of Ordinances for the Village of Sugar Grove to repeal the aforesaid provision.

NOW THEREFORE BE IT ORDAINED, by the Board of Trustees of the Village of Sugar Grove, Kane County, Illinois as follows:

SECTION ONE: Title 3, Chapter 11 – Raffles of the Village Code of Ordinances is hereby repealed in its entirety and shall be replaced with the following:

The Village of Sugar Grove has adopted an intergovernmental agreement with the County of Kane pertaining to raffle licensure. Licensure of raffles to be conducted within the corporate limits of the Village shall be obtained via permit issued by the County, and all such raffles are subject to the Illinois Raffles and Poker Runs Act, any County ordinance, rules, or regulations pertaining to raffles, and any other applicable law, as may be amended from time to time. The Village shall recognize any County-issued raffle license as valid within the

corporate limits of the Village.

The imposition of the penalties authorized by this Code for a violation of this chapter shall not preclude the State's Attorney from instituting appropriate action to prevent unlawful raffles or to restrain, correct or abate a violation of this chapter or of the conditions of a raffle license issued pursuant to this chapter or as otherwise authorized pursuant to State or Federal law

SECTION TWO: GENERAL PROVISIONS

REPEALER: All ordinances or portions thereof in conflict with this Ordinance are hereby repealed.

SEVERABILITY: Should any provision of this Ordinance be declared invalid by a court of competent jurisdiction; the remaining provisions will remain in full force and effect the same as if the invalid provision had not been a part of this Ordinance.

EFFECTIVE DATE: This Ordinance shall be in full force and effect on and after its approval, passage and publication in pamphlet form as provided by law.
